

# NOTICE OF RACE

## 2005 US Windsurfing National Championships

*Hosted by VMG Events*

July 25 – 30, 2005

Hood River, Oregon

### 1. INVITATION

1.1 US Windsurfing, the Columbia Gorge Windsurfing Association, and VMG Events, cordially invite you to attend the 2005 USW National Championships to be held Monday, July 25 through Saturday, July 30, 2005 on the waters of the Columbia River in Hood River, Oregon.

### 2. LOCAL ORGANIZING AUTHORITY

2.1 The Regatta is recognized and sanctioned by US Windsurfing as the 2005 National Championships. The Local Organizing Authority will VMG Events for and on behalf of and under specified conditions laid down by IFWC, ISAF, USW and CGWA.

### 3. VENUE

3.1 Racing will take place in Hood River, Oregon, USA on the Columbia River. The weather conditions in July are influenced by cool ocean air moving through the Columbia River Gorge to the heat of the inland deserts. Air temperature: 75-100 F  
Water temperature: 75 F Winds: predominantly West 10-25 knots Current: 3-5 knots

### 4. RULES

4.1 This is an ISAF sanctioned event governed by:

- The Racing Rules of Sailing 2005-2008 ([www.isaf.org](http://www.isaf.org))
- The IFWC 2005 Class Rules & Racing Guidelines ([www.formulawindsurfing.org](http://www.formulawindsurfing.org))
- This Notice of Race ("NOR") and Sailing Instructions (SIs)

4.1.2 Alterations to the SIs must be approved by the Race Director.

4.2 Competitors shall attend the opening & closing ceremonies including the dinner, and awards ceremony.

### 5. ELIGIBILITY

5.1 Competitors shall comply with ISAF Regulation 19, Eligibility Code. ([www.isaf.org](http://www.isaf.org))

5.2 A minimum of 1 race is required for a valid Regatta.

5.3 All US-based competitors shall be US Windsurfing Members. Competitors may join US Windsurfing on site for US \$30.00.



5.4 Foreign competitors shall be a member of a National FW Association or of the IFWC. National Associations shall be paid members of the IWA.

5.5 Membership formalities can be completed on site.

## 6. CLASSES / DIVISIONS

6.1 For the determination of the USW National Champions, the discipline will be Course Racing. Slalom results will not be counted in a competitors' overall score.

6.2 A **minimum of 5 entries** is required to constitute a 'class' or a division within a class.

6.3 A competitor must have reached the minimum age limit, in the relevant division, by Dec. 31, 2005.

6.3.1 A competitor must not be older than the maximum age limit, in the relevant division, by Dec. 31, 2005.

## **7. EQUIPMENT**

7.1 All competitors may bring their own equipment that complies with rules. Equipment will be available for charter. Check [www.vmgevents.com](http://www.vmgevents.com) for updates.

## **8. MEASUREMENT**

8.1 It is the responsibility of each competitor to ensure that his/her board and equipment conforms to the Class Rules.

8.2 The measurers will pay special attention to sail identification rule compliance.

8.3 Measurement and equipment checks may be made throughout the event.

## **9. SAIL INSIGNIAS**

9.1 All sails shall comply with Appendix B 2.4 Windsurfing Competition Rules of the RRS 2005-2008 ([www.isaf.org](http://www.isaf.org)). Competitors must register with the sail number they plan to race with or notify the Race Committee in writing of any changes before racing.

## **10. LIABILITY**



10.1 Competitors take part in all races at their own risk. The Organizing Authority, US Windsurfing, ISAF, FW Class, IWA or any of their officials or representatives or the sponsors or their officials or representatives are not responsible, under any circumstances, for any damage, loss or injury either ashore or on the water either to persons or equipment, which may result. Participation in this event, supporting events and in each race in them is at the sole discretion of the sailor and at his/her own risk.

## 11. COURSES

11.1 Courses will be specified in the Sailing Instructions and on the official Notice Board.

## 12. SCORING

12.1 The Alternative Scoring System, Appendix B 8.3 of the RRS 2005/2008 will apply ([www.isaf.org](http://www.isaf.org)).

12.2 Slalom will be scored separately. The Alternative Scoring System, Appendix B 8.3 of the RRS 2005/2008 will apply ([www.isaf.org](http://www.isaf.org)).

## 13. PROTESTS

13.1 A Protest Committee will be appointed in accordance with the RRS 2005-08 90a ([www.isaf.org](http://www.isaf.org)).

Their decisions will be final and cannot be appealed.

## 14. SAILING INSTRUCTIONS (SIs) / EVENT PROGRAM

14.1 The Regatta SI's will be available at registration as will the Event Program, scheduling social events.

## 15. SCHEDULE

## 16. MEDALS AND PRIZES

16.1 Medals may be awarded up to the top three Men/Women in each Class/Division depending on entry numbers. Prize categories and the actual number of prizes to be awarded in each properly constituted division will be posted on the official notice board after the close of registration and before the first race.

## 17. TELEVISION AND MEDIA

17.1 In registering for the event, competitors automatically grant to VMG Events the right in perpetuity to make, use and show from time to time at their discretion, any motion pictures, still pictures and live, taped or filmed television and other reproduction of them, taken during the period of the event, (*cont.*) for the said Championship as defined in the Notice of Race and Sailing Instructions in which he/she participates without compensation.

## 18. BIBS & COMPETITOR SAIL BRANDING

18.1 During racing, competitors may be required by the organizers to wear bibs carrying the event sponsors' branding, and carry the event sponsors' advertising on their sails. The maximum size of the event-advertising sticker is 600mmX1000mm. The sticker may not be cut or trimmed in any way.

## 19. REGISTRATION

19.2 Competitors will be required to produce the following prior to completing registration formalities on site:

- Official Entry Form
- Gear Registration Form
- Parental/legal Guardian Assent - for those under age of 18
- US Based competitors must show their Official USW membership Card or join USW on site if they wish to enter.

## 20. ENTRIES & PAYMENT

20.1 VMG Events must receive the completed entry form and early fees (see Fee Schedule below) by June 1, 2005.
